

# König Felt Touch-Up Dye Pen

## Intended Use

- For the glazing dyeing of scratches and abrasions on stained and lacquered wood surfaces.
- For colour preparation and touch-up during surface repair work.
- Recommended for indoor use.

## Characteristics

- Dries rapidly.
- Wipe-resistant and waterproof.
- Good adhesion to paint and wood surfaces that are free from dust and grease.
- Can be varnished with all König clear lacquers.
- Refillable with the relevant König Touch-Up Dye.

## Application Notes

Blend colour deposits in damp condition directly after application with the fingertip or a lint free piece of cloth to obtain smooth transitions. If glaze has already dried up, use Wire Wool or the Sanding and Polishing Cloth to adjust transitions or a too intense colour application. With soaking or raw wood surfaces, apply a barrier coat with König Universal Basecoat first to prevent the glaze from penetrating deeply into the wood fibre. Very smooth lacquer surfaces should be slightly roughened with fine wire wool or given a thin coat of König Special Repair Lacquer PLUS to ensure a good adhesion of the glaze. After use, put cap on firmly with a 'click' to prevent pen from drying up. Tips are consumables, which have to be replaced when worn out. If necessary, adjust sheen level with Special Repair Lacquer PLUS or Furniture Lacquer PLUS. Instead of applying too heavy coats, apply 2-3 thin misty coats from a distance of 30-40cm.

## Physical Properties and Shelf Life

<b>Dust-dry:</b>	after 1-2 minutes
<b>Touch-proof:</b>	after approx. 5 minutes (dependent on room temperature and coat thickness)
<b>Water resistance:</b>	good
<b>Adhesion:</b>	very good, except to PE/PP, limited adhesion to UV-hardened lacquer systems and powder lacquers without any problems – as far as known
<b>Overcoatable:</b>	without any problems – as far as known
<b>Shelf life:</b>	minimum 2 years (stored at room temperature, in unopened original container)

- Do not allow product to enter drains or watercourses.
